

## Terms and Conditions.

### ERADICATE. TICKET FOR A TONNE PROMOTION. TAKE A BREAK ON US!

3. All references to times and dates are to times and dates in Melbourne, Australia which may be Australian Eastern Standard Time ("AEST") or Australian Eastern Daylight Time ("AEDT") depending on the date.
4. All references to dollars or "\$" are references to Australian dollars.
